### 5.1. Extinguishing media.

#### SUITABLE EXTINGUISHING EQUIPMENT

INHALATION: Get medical advice/attention immediately. Remove victim to fresh air, away from the accident scene. If the subject stops breathing, administer artificial respiration. Take suitable precautions for rescue workers.

## SECTION 5. Firefighting measures.

### 5.1. Extinguishing media.

#### SUITABLE EXTINGUISHING EQUIPMENT

Extinguishing substances are: carbon dioxide and chemical powder. For product loss or leakage that has not caught fire, water spray can be used to disperse flammable vapours and protect those trying to stem the leak.

#### UNSUITABLE EXTINGUISHING EQUIPMENT

Do not use jets of water.

Water is not effective for putting out fires but can be used to cool containers exposed to flames to prevent explosions.

### 5.2. Special hazards arising from the substance or mixture.

#### HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

In the case of fire, use jets of water to cool the containers to prevent the risk of explosions (product decomposition and excess pressure) and the development of substances potentially hazardous for health. Without adequate ventilation, vapours may accumulate at ground level and, if ignited, catch fire even at a distance, with the danger of backfire. Avoid bunching of electrostatic charges. When performing transfer operations involving large containers, connect to an earthing system and wear antistatic footwear. Vigorous stirring and flow through the tubes and equipment may cause the formation and accumulation of electrostatic charges. In order to avoid the risk of fires and explosions, never use compressed air when handling. Open containers with caution as they may be pressurised. Do not eat, drink or smoke during use. Avoid leakage of the product into the environment.

Store only in the original container. Store the containers sealed, in a well ventilated place, away from direct sunlight. Store in a well ventilated place, keep far away from sources of heat, naked flames and sparks and other sources of ignition. ### 8.2. Exposure controls.
